The Oneida County Department of Mental Health (OCDMH) was recently awarded a grant from the Institute for Intergovernmental Research (IIR) #190963 in response to their application for the Reaching Rural 2023 Implementation Fund solicitation, aimed at supporting rural practitioners as they grow as leaders and advance solutions to address the challenges of substance use in their communities. The full grant amount was \$100,000.00 for an 18-month period, from March 1, 2024 through July 31, 2025. The County has also entered into agreement #192974 with the Center for Family Life and Recovery as a subrecipient of this award for the duration of the IIR agreement.
